

Election Schedule of Lower Dir Chamber Of Commerce & Industry

*For the Year 2024-25*

Approved by the Executive Committee Members in the Meeting held on 20 July 2024.

S.NO	Deadline	Description
1	20-07-2024	The Executive Committee will approve the Election Schedule for the year, 2024-2025 and nominate of the Election Commission.
2	22-07-2024	The Secretary General will display the election schedule on the notice board, website and also submit to the Director General Trade Organization within one days of the approval of the election schedule.
3	25-07-2024	The announcement of the election schedule, members/ firm desiring to change their representative shall intimate changes regarding name of representative to the secretary General along with necessary proof of eligibility.
4	01-08-2024	The Secretary General shall display within seven days of the announcement of election schedule, the provisional list of all members eligible to vote along with their NTN, STRN if applicable, the name and CNIC number of their representatives at the Notice board/Website.
5	05-08-2024	The members who have any objection to the entries/changes in the list of the voters shall send their objection in writing to the Secretary General within two days of issuance of said list.
6	12-08-2024	The Secretary General will intimate action on the objection or changes sent by members within five days from the list day under preceding clause.
7	17.08. 2024	Any member aggrieved by the decision of the Secretary General may make a representation within three days to the Election Commission.
8	20-08-2024	The election commission shall decide the case within three days.
9	23-08- 2024	Within two days of the decision of the Election Commission or in the case Commission fails to decide within the stipulated time, any person aggrieved by decision of Commission may appeal to the Director General, Trade Organization (DGTO) who shall decide the case within 10 days and his decision in this regard shall be final.
10	26-08-2024	Within two days of the decision of the Regulator or if no appeal has been filed with the DGTO, the final voter list shall be displayed and supplied to all member within 15 days or the decision of Election Commission.

11	28-08-2024	Within four days of the final voter list, any member who eligible to contest the election for the vacant posts shall send his nomination paper on the prescribed form duly proposed and seconded by a duly registered voter and signed by the candidate to the Secretary General. In same manner women entrepreneurs desiring to contest the election for the women reserved seats in the Executive Committee will submit nomination papers. The Secretary General will also receive nomination form Town Associations for the Executive Committee.
12	02-09-2024	Within 24 hours of the receipt of nomination paper, a copy of the final list of voters shall be provided to each contesting candidate.
13	03-09-2024	The nomination papers shall be scrutinized by the Election Commission and the list of candidates shall be displayed within 24 hours of the last date of receipt of nomination papers including that of women seats.
14	03.09. 2024	The objections, if any, to the nomination of candidates can be filed to the Election Commission within 24 hours of issuance of the list of candidates including those of women seats provided the candidates for particular seat will file objection for the candidate of the same seat and for the same class.
15	05-09- 2024	The Election Commission shall decide on the objections to the nomination of candidates within two days.
16	07-09- 2024	Within two days of decision of the Election Commission or in case the commission fails to decide within the stipulated time, any candidate aggrieved by the decision of the Commission, may file an appeal to DGTO who shall decide within seven days and his decision shall be final.
17	09-09-2024	Notices for the Annual General Meeting shall be sent to all members at least 21 clear days earlier than the date fixed for the AGM.
18	10-09-2024	The Secretary General will receive the withdrawal forms from the nominee who want to withdraw from the election
19	11-09-2024	The final list of candidates shall be issued within 11 days of the decision of the Election Commission.
20	14-09- 2024	The polling for election of the candidates of the Executive Committee (Corporate Associate & Town Association) shall be held within three days of display of final list of candidate. The returning Officer shall declare provisional results on the same day.



21	14-09-2024	The members of the Executive Committee will elect one women nominee on the women reserved seat.
22	20-09-2024	Within six days of the polling, any person elected as member of the Executive Committee shall send his nomination for election as an office bearer duly proposed and seconded by an elected executive committee member and signed by the candidates to the Election Commission.
23	24-09-2024	The nomination paper shall be scrutinized by the Election Commission and list of candidates shall be displayed within 24 hours of the last date of receipt of nomination paper.
24	25-09-2024	The polling for election of office bearers shall be held within two days of displayed of final list of the candidates.
25	30-09-2024	The final result of election of members of the Executive Committee and Office Bearers shall be officially announced at the Annual General Meeting of the Trade Organization called for the purpose within 15 days of the date of polling under the preceding clause but not later than 30 <sup>th</sup> of September 2024. The final election results announced in the Annual General Meeting shall be displayed at the Notice board/Website and submitted to the Director General, Trade Organizations.
